

# KAURI FLATS SCHOOL CYBER SAFETY USE AGREEMENT FOR STUDENTS

### INTRODUCTION

Kauri Flats School uses a variety of technologies to enrich students learning. School wide networked computers, the internet, email, web publishing, pod casting and video conferencing as well as in school TV and video conferencing all bring great benefits to the teaching and learning programmes at Kauri Flats School.

Our school has rigorous cyber safety practises in place, which include cyber safety use agreements for all students.

The overall goal of the school in this matter is to create and maintain a cyber safety culture which is in keeping with the values of the school and legislative and professional obligations.

This use agreement includes information about your obligations, responsibilities and the nature of possible consequences associated with cyber safety breaches which undermine the safety of the school environment.

All students will be issued with a use agreement and once signed consent has been returned to school, students will be able to use the school ICT equipment.

## **RULES TO HELP KEEP KAURI FLATS STUDENTS SAFE**

- 1. I cannot use school ICT equipment until my parents have signed my use agreement form and the completed form has been returned to school
- 2. I can only use the computers and other ICT equipment for my school work and only with my teacher's permission
- 3. I can only go online or use the internet at school when a teacher gives permission
- 4. I will not use the internet, email, mobile phone or any other ICT equipment to be mean, rude or unkind about other people or to tell anyone things like my full name, my home address or phone number
- 5. If I find anything that upsets me, is mean or rude things I know are not acceptable at our school, I will;
  - i. Not show others
  - ii. Turn off the screen
  - iii. Get the teacher straight away
